Contest for Children

Regulations:

- art.1 The contest is organized by the Committee Mantova Danza, situated in Mantova, via Oberdan n°11.
- art.2 The contest is addressed to dancers between 7 and 12 years old, duet or groups where the average age is between 7 and 12. For dancers from 13 years onwards is provided a specific contest for dance schools.
- art.3 It is provided a category that will include all styles of dance.
- art.4 Each contestant (solo, duet or groups) has to propose a choreography, that can last at most 4 minutes, including a silence moment. Each contestant can participate in the same category with various choreographies.
- art.5 The semifinal of the contest will take place outside in the town's historical city centre on a stage 10 meters wide and 10 meters deep. The last round will take place on the stage of Teatro Sociale, 10 meters wide and 10 meters deep.
- art.6 They will be admitted to the contest's semifinal the first 50 competitors (solo, duet or groups). To determine the precedence of the enrolment it will be considered the date of the postmark.
- art.7 The application form must be sent to: COMITATO MANTOVA DANZA, VIA OBERDAN n°11, 46100 MANTOVA - ITALY, no later than April 10th 2009.
With the application form, completely filled in, the following documents must be enclosed:
– photocopy of the identity papers for each contestant
– authorization for the people under 18 from who exercise the parental authority
– passport photo for each contestant and for the person in charge
– photocopy of the health certificate for a non competitive activity for each contestant
– deposit receipt of 80 euro for soloists, 140 euro for the duets, 180 euro for the groups, with bank transfer made out to:

no refund is due in case of renuncia
- art.8 Contest's organization will not consider the application forms without the records specified in the previous article n°7, and neither the application forms posted late, within the date appointed. With regard to this will be considered the date of the postmark.
- art.9 The contestants must have a CD with single track and a copy, with a label with the following details:
– title of the choreography
– name of the soloists, of the duets, of the group or of the school and choreographer's name
It is allowed the presence at the direction of only one person in charge for each solo, duet or group.
- art.10 For each contestant (solo, duet, group) is expected 10 minutes of rehearsal, before the exhibition. The plan with the timetable and the schedule will be at your disposal a week before the event on the web site www.mantovadanza.it
- art.11 Scenographies are not allowed. Only objects of setting, using by the contestants, can be utilized, except for ele-

ment and things which could cause damages to the dance carpet (fire, water, wax, talcum powder etc.....).

art.12 Semifinal

it will take place Friday April, 30th, Saturday May 1st, 2010, in accordance with the order appointed by the Organization, which it will must strictly respected.

art.13 Final round

they will be admitted to the final round 10 contestants for each category, who has win the semifinal. the plan of the rehearsal and the exhibition's plan for the final (may, 2nd) will be comunicated to the finalists.

art.14 April, 2010, Sunday 2nd, at the end of the contest, the jury will communicate the results.

art.15 Jury's decisions are unquestionable.

art.16 The jury of the contest children category will be composed by 3 international personalities of the dance's world. Names of the members of the jury will be divulged on the web site www.mantovadanza.it at the end of February 2009

Jury reserves the right not to assign the prizes if there shouldn't be any contestants with the required qualification.

art.18 Every contestants has to undersign the declaration in the application form, with which they give up to any kind of remuneration for the contest and for the television shooting, recognizing that anything is due for their activity.

art.19 The organization has the right to make video-shooting and photos; the organization can make free use of the photo-video material.

art.20 Cancellation

The Organization has the right to cancel a section of the contest or the whole show in case of force of circumstances . in that circumstance the enrolment fee will be give back.

art.21 For every kind of argument will be competent the Tribunal of Mantova.
