COMPETITION RULES “48 HOURS”

ART.1- The competition is organized by COMITATO MANTOVA DANZA based in Mantua in the Bonomi 17 street.

ART .2 –The competition provides for a single section that brings together all the dance styles (classical, modern-contemporary, hip hop) and all categories (juniors from the age of 12 years, seniors and professionals). Can participate in the competition companies, groups and dance schools.

ART.3 –The competition will take place on a stage of 10 mt .of dept x 12 mt. of width in the days of Friday 4 may 2012 (semifinal) and Sunday 6 may (final stage). You can book tickets for the entrance of the event and the price of tickets is 12 € a day.

ART.4 – Since the competition was born with precise purpose to bring out the real technical skills, but also artistic and creative competitors, candidates will request a double test. Therefore, the stage of the competition will be two. Semifinals: during this phase is required to be in the scene of a work in which will be assessed not only the technical preparation but also the choreographic originality, creativity, consistency between musical selection, title of the song and performance archived. Final phase: will be allowed to stages final 10 competitors. During the proclamation of the finalists, which will be at the end of the semifinal, the president of the jury will communicate to candidates finalists a title on which the groups will have to work. It will be the same president of the jury to also provide the piece of music on which the lie groups would need to develop new choreography. The new and unprecedented choreographic creation must therefore be consistent and develop the theme assigned. The criteria of judgment will be the same as those in the semifinals, giving more importance to creations more relevant, most original and creative. The finalists will have a room of rehearsal for a total of four hours. There are no rehearsal on stage in the theatre. The semifinal access competitors who have submitted an application for registration with the relevant documentation within and not later than the March 31 2012. The entrances are limited to the number of available places. The final stage entering competitors considered warty at the basis of the final judgment of the jury responsible.

ART.5 – For the semifinals each contestant must submit a choreographic composition whose duration must not exceed 4 minutes. For the final stage choreography should not exceed 5 minutes.

ART.6 – The registration form will be sent to: COMITATO MANTOVA DANZA, Bonomi 17 street, Mantua 46100 – Italy within and not later than March 31 2012.

To the registration form, completed in each part, it will be enclosed these documents:

- form to read and subscribe by all of the dancer and responsible
- fotocopy of proof of identity

In the case of cancellation for any reason, the registration fee will not be refunded.

ART.7 – The organization of the competition will not take into account the applications without the required documentation in the previous article 6, neither of those that will be sent later than the date term-indicated; in this regard is the postmark date of dispatch.

ART.8 – Candidates must be fitted with CD with single track and a copy, labeled with the following data:

- title of the choreography;
- the name of the group or of the school and the name of the choreographer and teacher. Is allowed on the direction of a only one responsible for each group.

ART.9 – The program with the opening hours of the competition will be available one week prior to event on the site: www.mantovadanza.it

ART.10 – Is not allowed scenography. Are allowed only objects of the scene provided by the participants themselves, to the exclusion of products or items that may damage the state of the carpet dance(ex: fire, water, wax, talcum powder etc...)

ART.11 – The result of the semifinals will be announced at the end of the semifinal itself. The award ceremony of the competition will take place at the end of the final phase.

ART.12 – The decisions of jury ,at every stage of the contest ,are unquestionable.

ART.13 – The jury of the competition will be composed of international personalities from the world of dance, and the name of the jury will be made known to the month of January 2012 through the web site: www.mantovadanza.it

ART.14 – Single premium first prize. During the competitions will be awarded scholarships and special mentions according to the final judgment of the jury.

ART.15 – All competitors must sign the registration form the declaration with which renounce any compensation for the conduct of the competition and for any filming, recognizing that nothing is due to them for the work carried out.

ART.16- The organization reserves the right to carry out the video and pictures ; the organization may use freely of material photo-video product.

ART.17 – ANNULMENT

The organization uses the option to cancel a section of the competition or the entire event if there are reasons of force majeure is proven. It will also be necessary to reach the minimum number of subscribers in order to be able to achieve the competition , in case this does not happen , the competition will be canceled, in which case the registration fees will be returned.

ART.18 – For any dispute will be under the jurisdiction of the FORUM OF MANTUA.
